1. Scope of Work

The Artist agrees to provide professional voice-over narration for a narrative story consisting of approximately 4,010 words spanning 20 pages, as commissioned by the Company on behalf of its client.

2. Project Description

The voice-over will be used for a conference presentation at an industry event attended by sector leaders, innovators, and experts. The recording should convey a confident, warm, and engaging storytelling style appropriate for a professional audience.

3. Delivery and Timeline

- The Artist will deliver the Final voice-over recording within 50 hours after receipt of the full script and creative directions.**
- Delivery format shall be high-quality WAV, MP3 or 48kHz files.**
- Minor revisions based on performance may be requested without additional fee.**

4. Usage Rights

- The company and its client are granted a nonexclusive license to use the recording for a**
Period of 8 months starting from the date of delivery.

- **Usage is restricted to conference presentation and internal client use (non-broadcast), worldwide territory.**
- **The Artist retains all rights beyond this license period.**
- **The recording shall not be used, in whole or in part, for training, developing, or feeding any artificial intelligence (AI) or machine learning systems, nor for any AI-related applications, products or services.**

5. Payment Terms

- **The total fee for services is \$2,000 USD.**
- **Payment will be made via bank transfer to the Artist's account.**
- **Payment will be processed within 10 business days following the Company's approval of the final delivered recording.**

6. Credit

The Artist shall be credited as the voice-over artist on the project materials or wherever credits are provided, where feasible, in the following format:

7. Confidentiality

- **The Artist agrees to maintain confidentiality regarding the project details, client identity, script contents, and all related materials.**
- **No information may be disclosed to third parties without prior written consent from the Company.**

8. Independent Contractor Status

- **The Artist acknowledges that they are an independent contractor and not an employee or partner of the Company.**
- **The Artist is solely responsible for payment of any taxes, insurance, or other obligations arising from the services rendered.**

9. Ownership and License

- **Upon full payment, the Company receives the license to use the voice recording as defined in Section 4.**

- All intellectual property rights remain with the Artist beyond the terms of the license.

10. Representations and Warranties

The Artist represents and warrants that:

- The recording will be original and will not infringe any third-party rights.
- The Artist has full right to enter into this Agreement and grant the rights described herein.

11. Termination

- Either party may terminate this Agreement with written notice if the other party materially breaches any term and fails to cure within 7 days.
- In the event of termination, payment will be made pro-rata for work completed.

12. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States.

13. Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to the subject matter and supersedes all prior agreements or understandings.
